

I-9 Lists of Acceptable Documents

We must comply with established Form I-9 procedures with one exception dictated by the Department of Homeland Security's Basic Pilot program: We will not accept documents that establish identity (List B) that do not contain a photograph. A revised version of the Lists of Acceptable Documents, reflecting current I-9 rules and the rules of the Basic Pilot program, is below. **Please refer to this list instead of the list included with the current I-9 form.**

Native American tribal document 5. U.S. Citizen ID Card (<i>Form I-197</i>) 6. ID Card for use of Resident Citizen in the United States (<i>Form I-179</i>) 7. Unexpired employment authorization document issued by DHS (<i>other than those listed under List A</i>)
